The faculty and staff of the Department of Nursing appreciate your interest in our Practical Nursing (PN) Program. This packet will help guide you through the application process and provide you with information about our Admissions Criteria and Selection Process.

The PN program at Manhattan Area Technical College is approved by the Kansas State Board of Nursing. It is a two-semester, fast-paced program that requires several prerequisites in science and general education courses. Individuals will complete academic and clinical courses to earn a certificate in Practical Nursing. The PN graduate is then eligible to take the NCLEX-PN licensing exam; successful completion enables the graduate to seek licensure as a Licensed Practical Nurse (LPN).

Admission into the program is competitive. Applicants must meet the minimum requirements of Manhattan Area Technical College and the Department of Nursing to be considered for admission to the Practical Nursing program.

Your <u>MATC Admissions Application AS WELL AS the required online Selective Admissions Application</u> and the documents listed within must be received on or before the 1<sup>st</sup> business day in March to be considered for admission into the Practical Nursing program. Any exception to this date would be at the discretion of the Dean of Nursing Education and Health Programs or designee. Additionally, Manhattan Tech encourages students to complete an advising appointment before the first business day in December of the preceding year.

Enclosed is information that is critical for a successful application—please read the entire packet carefully. We encourage you to make an initial campus visit appointment by <u>scheduling online</u>, for information about college admissions and the Practical Nursing program. The college website at <u>https://manhattantech.edu/PN/Admissions</u> also provides additional information.

# Academic Criteria

To be considered for admission in the Practical Nursing program, applicants must meet the following criteria and submit all requested credentials and documentation:

### To be given priority, prerequisite courses must be COMPLETED before THE APPLICATION DEADLINE to be considered for admission. Any exceptions to those standards are at the discretion of the Dean of Nursing and Health Programs or designee.

Applicants must have completed the prerequisite courses with a grade of "C" or higher and a minimum GPA of 2.0. \*Course can be completed as one or broken up as two courses (must add up to a minimum of five (5) credit hours). ^College Placement testing may be required to determine where you place in math and English. Consult your advisor for more information, and check well in advance of the semester when you plan to enroll in a math course.

The following criteria applies to <u>ALL</u> applicants:

### ✓ <u>Test of Essential Academic Skills (TEAS)</u>

- The Test of Essential Academic Skills (TEAS) is a requirement for program entry. The test must have been taken within three (3) years of applying to the program. Register for the TEAS through <u>RegisterBlast</u>. TEAS tests are limited to two attempts each academic year. An information sheet outlining the registration process for the exam is available on <u>pages 10-11</u>.
  - Applicants must score at least a fifty (50) in the math section and have an overall proficiency of at least basic.
  - Study guides for the TEAS may be helpful. The ATI version is available on their website. Generic ones are also
    available at bookstores. Look for Nursing Entrance Exams. Additionally, there are resources through Manhattan
    Tech's Teaching and Learning Center (TLC) and online through <u>Brainfuse</u>.
  - Students who complete their TEAS test at Manhattan Tech will not have to provide results. The Office of Admissions will verify the TEAS test scores. However, students who complete their TEAS test at another institution will have to follow ATI's process for ordering a <u>TEAS transcript</u> and have it sent to Manhattan Tech.

### ✓ Active Kansas Certified Nurse Aide (CNA) certification

- All Practical Nursing applicants are required to have an active Kansas Certified Nurse Aide (CNA) certification at time of
  completion of selective admission application. <u>CNA classes are available at Manhattan Tech</u>.
  - Manhattan Tech schedules CNA courses each semester. <u>Applicants who hold an active CNA certification from</u> <u>another state must complete the Kansas Department of Aging and Disability Services (KDADS) Interstate transfer</u> <u>application and schedule a time to test prior to the application deadline.</u> Contact the Kansas Department of Aging and Disability Services (KDADS) at 785-296-6877 to receive more information about this option.

The following criterion may apply, IF APPLICABLE:

# ✓ <u>Test of English as a Foreign Language (TOEFL)</u>

- Practical Nursing applicants whose primary language is not English must demonstrate English language proficiency before being accepted into the Practical Nursing program. The test used to measure English proficiency as set by Manhattan Tech, according to the KSBN requirements, is the Test of English as a Foreign Language (TOEFL):
  - Writing: 20; Speaking: 20; Reading: 19; Listening: 20

Each area must meet the minimum requirements in the categories listed above. Visit the <u>ETS website to get more</u> information.

The following criteria applies to <u>ALL</u> applicants:

### **Immunizations**

These requirements are in place for the health and safety of Manhattan Tech PN students and their patients. By contract with your academic institution, all students participating in patient care in this institution must meet the following health and safety requirements. All documentation must always meet requirements during a clinical course. The requirements outlined below must be current to apply to the PN program and participate in clinical hours. Refer to the immunization exemptions below for more information.

1) Measles, Mumps, Rubella (MMR) Documentation

a. Two (2) doses or proof of immunity by titer

- 2) Varicella (Chickenpox)
  - a. Two (2) doses or proof of immunity by titer
  - b. Will NOT ACCEPT HISTORY OF CHICKENPOX Chickenpox is an immunization that is often incomplete. We can only accept proof of vaccination or a titer. We cannot take anyone's testimony that you had chickenpox, not even a physician. Make sure that you have either vaccines or a titer. Paperwork for a low titer will not be accepted.
- 3) Tetanus, Diphtheria, and Pertussis (Tdap)
  - a. One (1) dose taken less than 10 years ago Please ask your healthcare provider to give you the TDAP vaccine.
- 4) Hepatitis B (Hep B)
  - a. Three (3) doses or proof of immunity by titer. If your titer is low or no immunity, you should get the vaccine.
     Paperwork for a low titer will not be accepted. <u>It could take up to 6 months to complete the series as required.</u>
- 5) COVID-19 Vaccination
  - a. Pfizer-BioNTech COVID-19 Vaccine series of two doses 3 weeks (21 days) apart OR;
  - b. Moderna COVID-19 Vaccine series of two doses 1 month (28 days) apart OR;
  - c. Janssen COVID-19 Vaccine single dose

### Immunization Exemptions

Manhattan Area Technical College does not require vaccinations. Manhattan Tech partners with multiple health systems and healthcare providers to provide clinical and programmatic experiences for our students; many of our clinical partners require all students to have received COVID-19 and other vaccines before their on-site experiences and training may begin. As a result, unvaccinated students could be precluded from participating in these activities, potentially impacting their ability to complete all program requirements. Students may seek a medical or religious exemption from a clinical partner's COVID-19 vaccination requirement. Approval for an exemption is dependent on the clinical site. Refer <u>online</u> for the detailed online immunization exemption process.

# **Nursing Essential Skills and Functional Abilities**

<u>Nursing Essential Skills and Functional Abilities</u> are the essential functions every nursing student is expected to perform and are necessary for successful participation in the PN program. This form will be completed online at the time the application is submitted. These are necessary to provide safe, ethical, and legal healthcare services. Students participating in the PN Program are expected to demonstrate the essential functions listed in this form, with or without reasonable accommodation. These are applicable in classrooms, laboratories, and clinical settings. The nursing program uses independent clinical education sites that may or may not be able to offer the same reasonable accommodations that are made available by the College. Any student wishing to request reasonable accommodations.

# Non-Academic Criteria Continued

### Background Check – COMPLETED UPON ACCEPTANCE INTO THE PRACTICAL NURSING PROGRAM

The completion of a criminal background check is one of the admission requirements to the Practical Nursing program. Specific requirements in regards to the background check will be given at orientation. The background check is required to ascertain:

- 1) The ability of students to eventually become licensed in the profession AND
- 2) The ability of students to attend mandatory clinical rotations at external facilities in accordance with the requirements of the program.

Because a criminal history can have different effects at the educational, licensure, and employment levels, when a person is considering pursuing a nursing career, it is best to have as much information as possible prior to deciding to enroll in a nursing program. Manhattan Tech encourages individuals who have criminal histories and who are interested in pursuing a nursing career to:

- 1) Contact approved nursing education programs and ask about the programs' enrollment criteria with respect to criminal convictions;
- 2) Review the criminal history information according to the Kansas Board of Nursing policy 65-1120\*; AND
- 3) Contact healthcare facilities and inquire about hiring criteria with respect to criminal convictions.

\*This regulation deems certain criminal convictions could result in denial or restriction of access to a Kansas nursing license. If you have any questions regarding criminal convictions, contact the <u>Kansas Board of Nursing</u> for additional clarification.

# **Acceptance Process**

Admission to the Manhattan Tech Practical Nursing program is determined through a competitive selection process. Submission of an application does not guarantee acceptance in the program. Refer to page eight (8) for the Practical Nursing Admissions Scoring Rubric.

If you are admitted into the Practical Nursing (PN) program without having all required prerequisite courses completed at the time of the application deadline, you will be required to have the remaining prerequisite courses completed with a "C" (2.0) or better before the PN program starts. Official transcripts will need to be submitted to the Registrar for these courses. This also applies to those who are placed on the alternate list and then asked to join the PN program.

After the application deadline, completed files will be scored utilizing the <u>Practical Nursing scoring rubric</u> and applicants that completed an online Practical Nursing application will be notified of their acceptance, alternate, or denied status. <u>Notification will be emailed via</u> <u>MATC email on the first week of April.</u> Students should make sure the MATC email is working for application status. This is the official form of communication for the college.

Applicants offered a seat in the program must complete an online letter of intent indicating their plan to accept or decline enrollment in the nursing program by the date designated in the notification. In addition, a <u>non-refundable \$100 deposit</u> must be paid when accepting a seat in the program and will be applied toward program tuition and fees at the start of classes. A student choosing to defer or withdraw their intention will forfeit their deposit.

Failure to respond will result in forfeiture of a seat in the Practical Nursing Program.

# **Student Responsibilities Upon Acceptance**

After acceptance to the program, students will be required to attend program orientation (generally held in May). Students will be notified of the date and time of the orientation in the acceptance letter.

Specific information about the bulleted requirements below will be provided at orientation and will need to be completed by the first day of classes. Please do not submit TB skin tests before you receive information at orientation. Students are also required to provide documentation of the following items prior to the first day of class:

- ✓ Electronic devices\*. Laptops are required for the program. Windows-based devices are preferred.
- Comprehensive Physical Exam Along with meeting all the Nursing Essential Skills and Functional Abilities, a 'Physical Exam' form will be provided at orientation. Students are required to obtain a physical exam within one (1) year before the start date to verify that there are no major health issues that may affect full participation in Practical Nursing program and the clinical and lab exercises.
- ✓ TB Skin Test (one or two may be needed) Students are required to have a TB Skin test performed and provide documentation of the test results. Information provided at orientation.
- ✓ BLS certification Students must have a Healthcare Provider Level BLS certification from American Heart Association that will be active (not expire) throughout the nursing program. Red Cross BLS certification is not accepted.
- ✓ Background Check <u>http://scholar.verifiedcredentials.com/?organization=matc</u> (The student is responsible for the additional fee).
- ✓ Drug Testing Verification of a negative drug screen is required by the college's clinical partners for the student to participate in the clinical portion of the nursing programs. (*The student is responsible for the additional fee*).
- ✓ Health insurance—students are required to hold health insurance during their enrollment at MATC in thenursing program.

Failure to provide the items listed above may result in dismissal from the program.

# **Electronic Requirements Upon Acceptance\***

All PN students are required to own and bring a laptop to class that meets the following criteria:

- Operating System Microsoft Windows 10, Apple OSX 10.14 Mojave, or Ubuntu 20.04 LTS or newer
- Processor/Memory Intel Core i5 or AMD Ryzen or better, 8GB of RAM for typical use
- Microsoft Office is required; MATC provides this software package to students enrolled in full time programs. Find out how to get yours <u>HERE</u>.

# System Requirements to View Manhattan Tech Courses – PN Program

In order to view the necessary components of MATC courses, it is vital that the following items be functioning on your computer. Please keep the following information in mind:

- Laptop: Window 10 recommended
- Chromebooks and tablets are <u>NOT</u> supported by the testing software
- Browser We recommend a browser such as Mozilla Firefox or Google Chrome
- Internet Connection: cable or DSL highly recommended; accessible and reliable connection necessary

# Reapplication

Applicants who are not selected for admission and are looking to reapply must complete a Practical Nursing Application Packet and submit it by the next application deadline. Manhattan Area Technical College Admissions Applications are good for three (3) years. No documents submitted in previous application cycles are available for students and will need to be resubmitted. Those not selected for admission are encouraged to talk with their advisor about how to increase their admissions scores and are required to submit a new packet.

If an applicant does not have a score on a particular row, then the student does not qualify for priority admission and their application will be reviewed on a case-by-case basis. Students who do not qualify for admission are encouraged to follow up with an academic advisor to see what they can do to improve their scores.


Any applicant utilizing a class higher than Intermediate Algebra on this rubric will score a bonus point in the math section.

# **Explanation of Immunization Requirements**

All immunizations below need to be completed and submitted with the selective admission application. Religious or Medical Exemption procedures are noted on HERE.

Refer to the <u>CDC's Recommended Child and Adolescent Immunization Schedule</u> for additional guidance.

# MMR (Measles/Rubeola, Mumps, & Rubella)

Options to meet this requirement:

- 1. Provide a copy of proof showing a positive IgG antibody titer for Measles/Rubeola, Mumps and Rubella.
  - a. If the titer results are POSITIVE, attach a copy of the lab results to the nursing admissions application.
  - b. If any of the titer results are NEGATIVE or EQUIVOCAL, you must get your MMR series. After the first shot you will be required to complete the second MMR after 28 days and submit proof to Manhattan Tech.

### <u>OR</u>

2. Show proof of or complete one series of MMR immunizations. One "series" of immunizations includes immunization for each disease on separate dates at least 28 days apart.

# Varicella (Chickenpox)

Options to meet this requirement:

- 1. Provide a copy of proof of positive IgG antibody titer for Varicella
  - a. If the titer results are POSITIVE, attach a copy of the lab results to the nursing admissions application.
  - b. If the titer results are NEGATIVE or EQUIVOCAL, you must get your first Varicella vaccination and the second Varicella must be completed after 30 days and submit proof to Manhattan Tech.

### OR

2. Show proof of or complete one series of Varicella immunizations. One "series" of immunizations includes two shots separated at least 30 days apart.

# Tetanus/Diphtheria/Pertussis (Tdap)

### Options to meet this requirement:

1. You must provide proof of Tdap vaccination, followed by a Tdap booster every 10 years.

# Hepatitis B (Hep B) - Series could take up to 6 months to complete so plan accordingly.

Options to meet this requirement:

- 1. Provide a copy of proof showing a positive IgG antibody titer for Hep B.
  - a. If the titer results are POSITIVE, attach a copy of the lab results to the nursing admissions application.
  - b. If the titer results are NEGATIVE or EQUIVOCAL, you must get your Hep B series. You must obtain the first injection, then the second injection is given 1 to 2 months after the first dose, and the third injection is 4 to 6 months after the first dose.

### OR

2. Show proof of or complete one series of Hep B immunizations. You must obtain the first injection then the second injection is given 1 to 2 months after the first dose, and the third injection is 4 to 6 months after the first dose.

# COVID-19 Dose(s)

### Options to meet this requirement:

1. Pfizer-BioNTech COVID-19 Vaccine series of two doses 3 weeks (21 days) apart

<u>OR</u>

2. Moderna COVID-19 Vaccine series of two doses 1 month (28 days) apart

### OR

3. Janssen COVID-19 Vaccine single dose



# **Nursing Essential Skills and Functional Abilities**

Intellectual	Ability to collect, interpret, and integrate information and make decisions. Behavioral and Social Attributes	Possess the emotional health and stability required for full utilization of the student's intellectual abilities, the exercise of good judgment, the prompt completion of all academic and patient care responsibilities, and the development of mature, sensitive, and effective relationships with clients and other members of the healthcare team. Possess the ability to tolerate taxing workloads, function effectively under stress, adapt to changing environments, display flexibility, and learn to function in the face of uncertainties inherent in clinical/practicum settings with patients. Possess compassion, integrity, concern for others, and motivation.
